2. Timely pay all taxes due and timely file a Tax Remittance Report.
3. Respond in a timely manner to requests by the Tax Commission for information.
4. Accept service of process in matters arising from or related to the conduct of business related to this license.
5. Authorize the Comanche Tax Commission to conduct an on-site audit of my establishment and to inspect and obtain records within my control as necessary for audit purposes or to determine compliance with the Liquor Control Ordinance and Comanche Tax Code.

I further acknowledge that such license, if granted, is nontransferable and non-assignable, and that neither the Comanche Nation nor the Comanche Tax Commission shall be responsible for defending me in proceedings brought by federal, state, or local governments for the enforcement of tax or other laws. If I receive any summons to appear in any court, I will notify the Comanche Nation Tax Commission immediately and provide the Tax commission with a copy of the court document.
